



Action Item 1: Repeal of Standard 2.2(m)

Standard 2.2(m): Exceptional criminal cases

An exceptional criminal case is not exempt from the time goal in (j), but case progress should be separately reported under the Judicial Branch Statistical Information System (JBSIS) regulations.

Possible action: recommend repeal to CEAC
