Judge Maddock provided an update on the committee's July 2015 report to council (*Judicial Branch Administration: Final Report on Implementation of Judicial Council Directive 125*).

Judicial Council Report on Screening Program

Mr. Ellestad provided information on the "closeout" report on the Screening Equipment Replacement Program for FY 14–15, submitted for the council's October 27, 2015, meeting. The program replaces and services screening equipment in the trial courts. Its budget has not changed since the program began but equipment and service costs have increased significantly. A Budget Change Proposal will be submitted to bring funding up to the current costs for the service and replacement of equipment, to allow the program to continue to replace equipment on a regular basis and avoid catastrophic failures.

Amendments to California Rules of Court, rule 10.172

Mr. Giden provided information about technical changes to rule 10.172 (court security plans) that included updating references to the "Administrative Office of the Courts" and the disbanded "Working Group on Court Security," and shifting to the Court Security Advisory Committee the responsibility for reviewing the Court Security Plan submissions and notifications received by the Judicial Council through Security Operations.
