- **5. Question:** I understand your room rate limit is \$110.00 and your breakfast per diem is \$25.00. our guest room rates include complimentary breakfast, so will the maximum room rate of \$135.00 be considered.
 - **AOC Response:** unfortunately it cannot be considered. The maximum budget for guest rooms is \$110.00 per room, per night.
- **6. Question:** We are limited in our meeting space and wondering if one of the break out session on Monday could also be held in the General session meeting room? Would you also consider maybe one of our large guest room suites for a break out room?
 - **AOC Response:** Yes, we can use the General session for a break out session. We can also you an unfurnished guest suite for one of the group discussions (not break out session) as long as it can be set up in conference set up.
- **7. Question:** I've been informed by my corporate office that in order to send over my properties federal tax ID numbers (for attachment 5 of the RFP) I need to submit to them the email address of the main contact, and my corporate office will send over our ID number.
