5	At the Sacramento and Los Angeles Courtrooms, JCC identified substandard/variable lighting as a challenge for good video quality. Should additional lighting for videography be considered under the proposed scope for this project?	Pre-proposal tours and meetings of June 7 and 8, 2017	Any solution for improving the light in the space for videography can and should be considered. That doesn't have to be limited to additional lights. It could include painting areas of the wall or ceiling or other such options.
6	At Sacramento, will JCC consider a standalone split system for mechanical cooling that locates a condenser unit on narrow roof over the AV closet/hallway, or will such a unit be required to be located elsewhere, i.e. main roof?	Pre-proposal tour and meeting of June 8, 2017	<p>The small roof at issue is controlled by DGS/Historic/Planning. It is preferred that we tie into the existing chilled water system and eliminate the need for a secondary condenser. This assumes the room only needs cooling and not heat. Note: This will probably apply to all 3 courts</p> <p>Note: Designer must address the location of the access panel, HVAC Unit, Cooling Unit, Fire Sprinklers, Power and Lighting.</p>
