This Addendum #2 hereby modifies the RFP as follows:

- 1. Attachment 2 Work to be Performed, Section 7.a: Add the following language: "In the event of a loss, the AOC and Purchasing Group Members agree to notify Proposer within 30/45/60 days after the pick-up by Proposer of the securely sealed container in connection with which the loss is asserted; and, unless such notice shall have been given, such claim shall be deemed waived. It is agreed by the AOC, Purchasing Group Members, and the Proposer that they will work together to determine the extent of the loss, and if possible, the cause of the loss.
